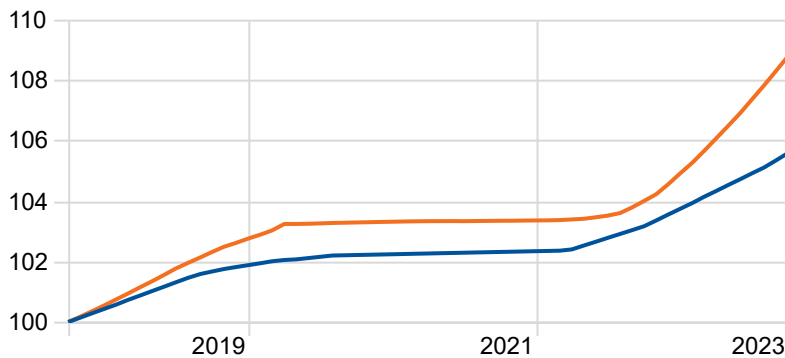

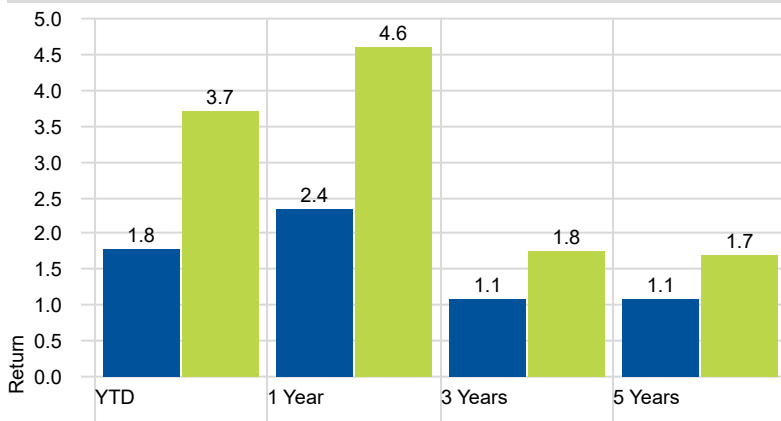
Investment Growth

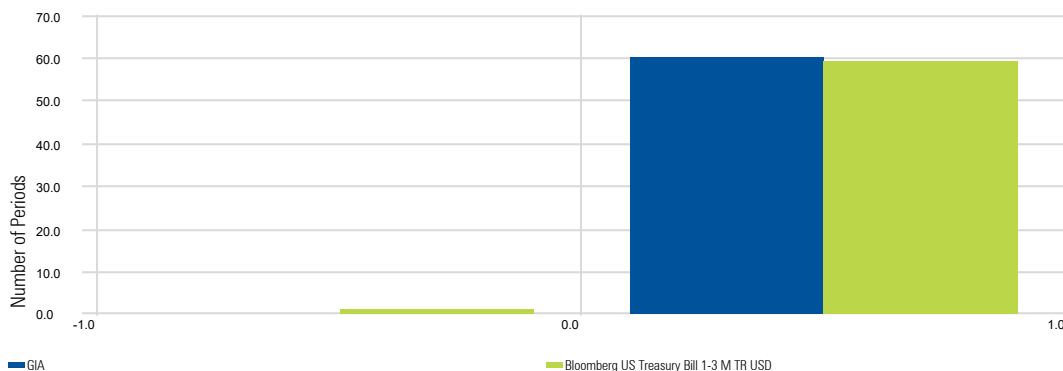
