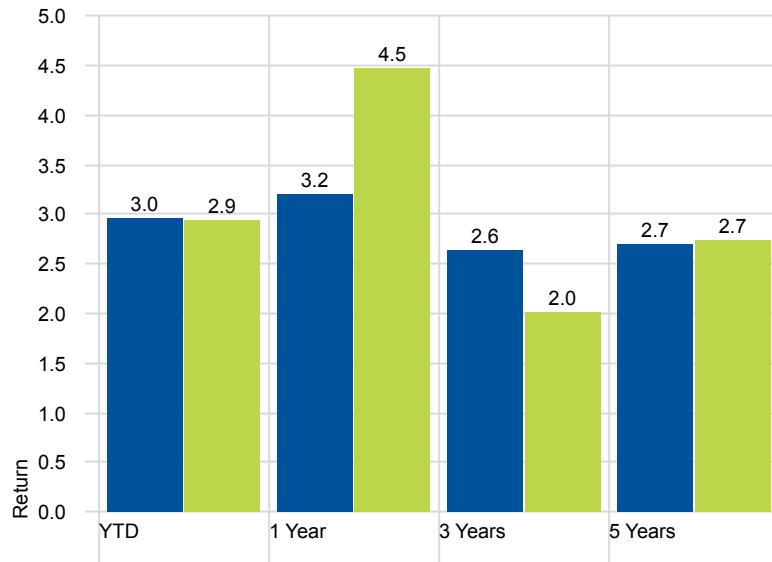

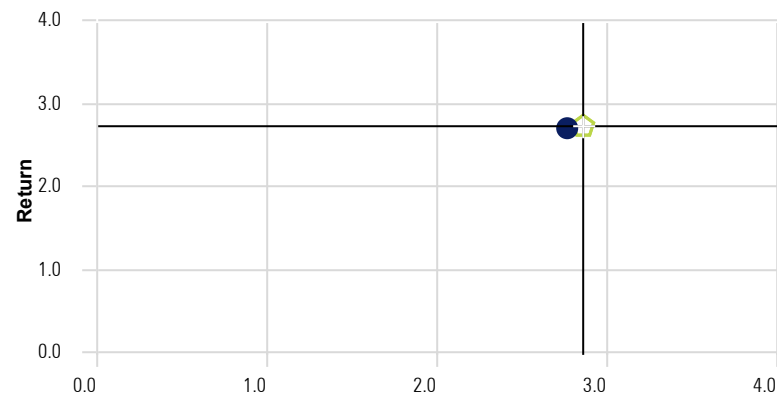

## Risk-Reward

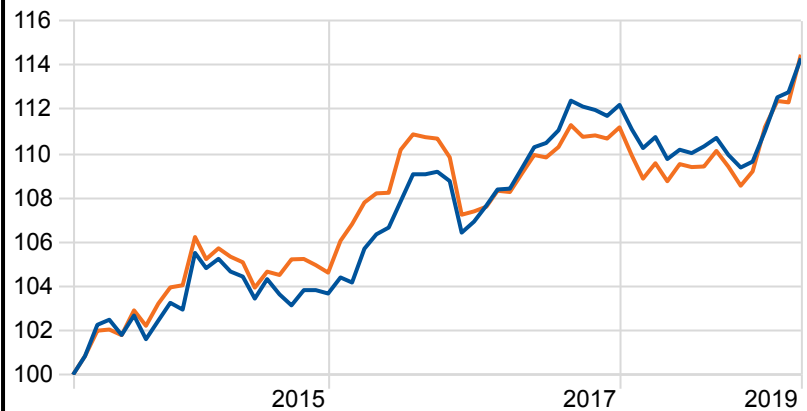

Time Period: 01/04/2014 to 31/03/2019



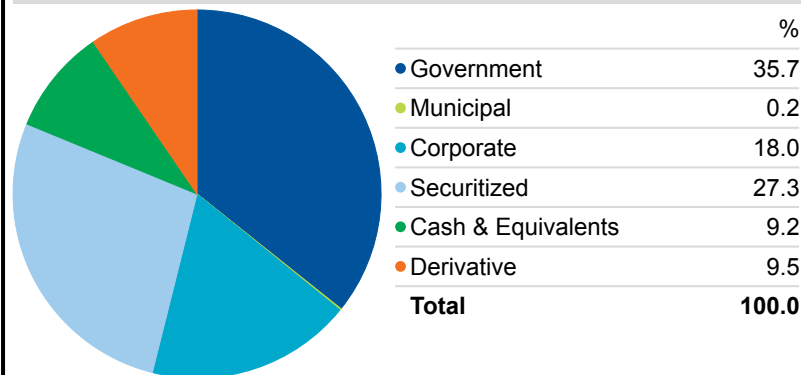
